Information for the competition

- Submission of documents: All documentation must be submitted online no later than 5 days before the start of the competition (deadline: 09.10.2025). Documents brought to the competition will not be accepted.
- Getting the forms: You can pick up team registration forms from the referees, the team entry form and player sheets for qualification rounds will be provided. For the semifinals, matches for 3rd place and the finals - the documents will be provided on Thursday after the end of qualifying.
- Player sheets (Info): Please fill in all relevant information: name and surname of the player, NBC ID number, country, name and surname of the coach and his NBC ID number. After each player finishes he must sign his players sheet.
- Substitution info: According to point 8.5.1 under c) ISO) - Before the start of the match each team receives 4 "player sheets" for substitution.
- Team entry form submission: For qualifications – 75 minutes before the schedule of first player.
- Submission of the list for playing: For qualifications - according to point 8.3.2.1 ISO - Player must register to the referees no later than 30 minutes before the official start with his individual player sheet. If he fails to do so he loses the right to play. A player who competes in the qualifications for team competition is also considered an individual player.
For semi-finals, 3rd place matches and finals - according to point 8.3.2.2.1 under b) ISO - The submission of players list for both teams for the match must be done no later than 30 minutes before the start of the match. Positions 1-6 on the application are also the order of playing of both teams. The entire team must introduce itself to the referees no later than 30 minutes before the official start of the match. If any player is not present, he loses the right to play.
- Playing equipment: The playing equipment of individual players is subject to the provisions of the regulations for club teams (point 7.5 ISO). - Club teams must have the club emblem and / or club name on the jersey.
- Notes for Coach: For offenses, indiscipline and violation of fair-play, a warning by the SpO. They take their place before set start, and they can leave at any time, but they cannot return during the set, only the beginning of the next set.
- Presentation of players on the lanes: Semifinals, matches for 3rd place and finals - the whole team 10 minutes before the start of the match - the teams for the match are on the lanes, the referee announces the match and makes a presentation, sports salute.
- Players entry and announcement of results: entry accompanied by a referee, each player goes to his starting lane, at the referee's signal the time starts, the warm-up begins. During the warm-up, individual players will be introduced. After the end of the match, the players on the referee's command signal go to the top of players space and the results are announced.
- Starting the match, stopping and changing lanes: always at the referee's signal, time starts at the referee's signal.
- Cleaning playing space: Host of competition must provide person who cleans the playing space
- Photographing and recording: it is possible to take pictures and record players from the lane area during first three minutes of the warm-up.

Additional information for clubs

- Clubs that have not paid the entry fee must pay before first player starts to play. The club can't start play without a paid entry fee.
- Clubs that have advertisements on the jersey must send a request for approval of the advertisement to the NBC.
- The mandatory documents required for a person to be eligible to participate are: **Photo, signed Anti-Doping Statement (AD) and signed Conditions of Participation (CoP) - for the current season. Five days before the start of the competition, it is no longer possible to submit documents and the list is final. Missing documents should be sent to the email: registration@wnba-nbc.com. Players or members of the delegation who do not have a required documents cannot participate in the competition.**

The host and / or Chief Referee may give some additional instructions for the competition before the start of the competition.
