14. No right to participation

- a) If the national federation, that has submitted application for the competition, is in arrears with due contributions, fees or other payments to the WNBA and/or to the NBC or another section, and/or the entry fee has not been remitted to an account of the NBC by the specified deadline. The NBC office will examine each case individually.
- b) If the registration form A, B and C are not filled out completely and clearly and/or are not coming in with all required documents (AD agreement, submitting a photo of players and officials...) by the Office of NBC before lapse of the fixed terms.

- c) In the event of incomplete or late submission of the registration form A, B and C / entry fee, a participation is only possible if the President of the NBC approves and a penalty fee of 130 Euro for each individual incomplete or late submission has been paid to the NBC before the start of the event.

15. Organizational process

The organizational process is governed by the requirements of the NBC. Relevant documents are provided to the host / organizer available. The participating nations are meeting in the framework of technical details, where known for this. The schedule is created immediately after the deadline and asked the host / organizer and the Nations.

16. Permission of start, physical examination, and doping

The permission of start has all sportsmen:

- I. ECH and I. ECH U23 see of the Invitation to competitions.
- they are reported on the registration form B and C until and 10 player's women and until 10 players men.
- they are physical fit for the requirements of the competition. About of the medical investigation will be referenced of point 7.4 the IR. By infractions or other health damages the organizer takes over no liability.
- they legitimize towards the chief of referees through a player pass. Photos over the in the competition to bearing player dress are given together with the player pass to the Chief of Referees.
- The Office of NBC notifies the chief of referees the permission of start from the nations named players and the assistant of the player, there is entitled.

The chief of referees will check at place the proof of identity of the sportsmen.

Doping

Doping is according the guidelines of the IOC, the Wada and the Anti-DOPING-RULES of the World Bowling (WB-Code) strict prohibits. Will be one offence against the anti-doping-rules ascertained in the frame of a control by competitions, will be cancelled the obtained results and if need be denied the medals. Further preventive measure – as admonishment, dissuasiveness, closing on term or lifelong closing – are after the numeric's 10.2 until 10.3 WB-Code. Decisive for the not allowed medicaments (things to doping) is the valid at time of the competition list of DOPING of the Wada – Prohibited List (www.wada-ama.org). Get pointed completing on the figure 2.5 SpO „Alkoholverbot“.

The Office of NBC are to transfer with the registration form B / C also the signed declarations of the sportsmen and also the signed declarations of the head of the delegation, trainer and further employee of the delegations after the Annex 2 of the WNBACode (look Annex at this invitation to competitions). Only a submittal of these declarations makes possible the right of start of the sportsmen from a nation by the both events. Not exists an explanation of one sportsman, so is only from this precluded from starting.

Should itself yield while of the competition suspicious facts, that sportsmen have taken in medicaments or alcohol, the basically or by reason of the quantity for sportsmen are prohibited, the arbitration board is legitimated, to order on a medical control. The involved sportsman is committed, to render this order consequence.

That is valid also for in advance not presaged, after closing of a competition queuing dope test. In the event of the refusal of sportsmen are the giving's in advance to transpose in the WNBACode.

By noncompliance of the prevention conditions exists no permission to start in the event.

17. Sportswear, Assistant

Country arm or association arm must be available on the playing dress. Before the technical meeting each nation must hand over to the chief of referees one or several colour photos with the playing dresses. The teams have to start up in uniform sport dress and playing dress (training overall, tricot, short and socks).

The advertising of up to a size of 400 cm² can be carried on the playing dress and additional at training overall likewise until to a size of 400 cm². Advertising for alcohol (excluded beer) and tobacco isn't permitted.

Advertising permits shall be submitted.

The coach / assistances of a player while of one match take place only, if the assistant

- a) is authorized through the NBC (registered on registration form B and C)
- b) is reported by name to the Chief Referee (name on the list of result of the player) and
- c) bears likewise sportswear and sports shoes.

18. Titles and Honours

To this look Implementing Regulation points 13 and 14 European Championship. The honours of winners get according to the giving's in advance in the schedule executed on Olympic kind.

19. National flag

Each nation is obliged to bring along their national flag and to keep ready the case of need through the event. The national flag is only to be given to the organizer, if he comes to you and say that he needs the flag.

Largeness of the flag: For affixing in the hall: 2 meters

20. Protests

A protest must be submitted in writing to the chief referee by the head of delegation, team leader or his representative or the sportsman immediately after the reason becomes known, and the protest fee of 100.00 EURO must be paid at the same time. If the arbitration board accepts the protest, the team submitting the protest will be refunded protest fee; if the protest is rejected, the protest fee will be forfeited to the benefit of the NBC.

For all other matters, reference is made to the NBC's legal and procedural rules.

21. Press

All Reporters have itself to accredit by the organizer. Reporter, they are arrived with a nation, are no members of the respective delegation.

The reporters have to identify itself each time through from organizer by the accreditation leaves press card.
